The county's Litter Heroes have been out with a vengeance during this year's Stop the Drop campaign!

Over recent years, spring has become the season for spring-cleaning the roadside verges in and around the villages of Northamptonshire.

Community litter picking evokes a strange mixture of emotions: it is an enjoyable social event, which reinforces a village's community spirit and undoubtedly makes a place more attractive. Nevertheless, you are left wondering – why on earth would people treat our community as a dumping ground? The only answer to this conundrum is – encourage people to join an organised litter pick and you are helping to spread the anti-litter message.



Organisers have reported to us that many children have been among the pickers, and this really helps to get the message out. There have also been many octogenarians – and all ages in between.



Some of the comments received from litter pick organisers:

"It is a different-but-fun social occasion and a great learning opportunity for children. Once they have helped collect other people's rubbish they will always think twice before dropping litter themselves.....Who needs a BA in Social Anthropology? Operation Spring Clean teaches you more about your fellow man than years of study ever could! The stuff that people throw into the hedgerows of our countryside is jaw dropping" (Bringtons & Nobottle)

"It was obvious from the items we found in the ditches that the culprits are outsiders who have indiscriminately filled them with their rubbish, having no regard or respect whatsoever for our countryside" (Little Houghton)

"We had a good 'pick' and the village now looks lovely and tidy" (Hellidon)

"My cat appeared at one stage, but had to be banned as she insisted on running backwards and forwards across the road" (Syresham)

Some of the bizarre litter items reported by enthusiastic pickers: a large unopened canister of soup; some speakers; an old sign reading "Northants County Council - NO LITTER - PENALTY £100"; a salt and pepper pot; a snakes and ladder game; one dead toad and fox; a quilt cover; part of a speed camera; an unopened pack of beer; hard alcohol containers; morphine based over-the-counter drugs; pornographic literature; endless fast food wrappers and "stuff that shouldn't be mentioned before the 9 o'clock watershed"!

With 25 million tonnes of rubbish dumped in the UK each year, it was no surprise that the popular BBC One documentary Countryfile has featured this issue. On March 6 John Craven investigated what is being done to clamp down on the litter louts and fly-tippers who are ruining our countryside, and we expect the programme to give even more coverage to litter in the coming months.

## High Speed Rail News update

We encourage everyone who lives in the south west of the county, or who has an interest in the way transport should be developed in the UK, to go along to a DfT consultation exhibition on HS2 (for details, see panel).

Ask them about your local concerns, the business case and the planned running speeds.

We support the principle of high speed rail, as part of the Government's welcome vision to make rail - as opposed to road or air - the long distance transport mode of choice. However, we do have very serious concerns about the way HS2 is being planned and consulted on, as well as the impacts of the proposed route itself. Moreover, 400 kph means straight line tracks, which means no latitude in routing, and probably too much noise, without any real benefits.

We know that those who see the issue in black and white – emphatically for or vociferously against – will want to accuse us of fence sitting. But the issue does require serious thought and analysis, which has always been CPRE's approach to contentious projects which aim to consume precious greenfield countryside.

## Roadside Clutter

### Necessary information - or a confusing blight?

We in CPRE Northamptonshire believe that there are far too many signs cluttering up the county's roads. Do you agree? If so, we would like to hear from you.

Of course, traffic signs are necessary in the interests of road safety. But too many signs are counterproductive, and they eventually become an eyesore, blighting the countryside. Some signs have definitely outlived their usefulness. In addition, some may even add risk to road users, by distracting drivers and/or concealing dangers. So what we would like you to do is to tell us about excessive signage on country roads in your neighbourhood, and we will take up the worst examples with the highway authority.

Twenty years ago, the village of Spratton (some 1200 residents) had a 30 mph limit with a simple speed roundel. Ten years ago, an additional village name sign was added, although this was completely unnecessary, as motorists had already passed such a sign. Six years ago, with the advent of the 20 mph limit, the monster sign (picture) appeared. All that is required under Traffic Regulations is a roundel.

We will be inviting Northamptonshire County Council to take seriously examples that we raise with them, in the spirit of the Coalition Government's "Cut the Clutter" initiative to get rid of unnecessary road signs and street furniture. We invite

## Planning Roadshow addresses Localism

As we go to press, Parish Councillors from all over the county have reserved their places at this year's CPRE Northamptonshire Planning Road Show on Localism (at Great Houghton Village Hall, Thursday April 14 at 6.30 for 7.00 pm – just a few places are still available – contact details for Sue Baylis are in the panel, right).

**The Localism Bill** could greatly assist rural communities and give them real power to protect the countryside, because it sets out to give local people a genuine role in planning for their neighbourhood. **The Localism Bill** could also open the way for developers to ride rough shod over the countryside. The proposed Neighbourhood Plans are a good idea in principle, provided local communities have the skills and resources to prepare them and they able to counter the most controversial developments. The right to appeal is not at present included in the Bill. CPRE's National Office staff is lobbying ministers and MPs on these points as the Bill works its way through Parliament, so watch this space!
